The Baptist Union Council is inviting churches and ministers to share their responses to a request to change Appendix 3 of the Ministerial Recognition Rules, through this consultation process in order to enable Council to respond to the question that has been asked.

This survey is designed to give Council a clearer picture of how our churches are engaging with issues of marriage and sexuality, together with any feedback about the specific question that you would like to be heard. It should take around 15 to 20 minutes to complete.

There are a few permissions questions that you need to respond to (marked with an asterisk), but otherwise questions are optional. You can move back and forward through the survey using the 'Prev' and 'Next' buttons at the end of each page.

At the beginning of the survey, you will be asked to give some information about your church, so you might want your most recent annual return details to hand to help with this. We are asking for this so that we can ensure that the overall survey feedback is representative of Baptists Together.

Same-sex marriage and the accreditation of ministers

Our current Ministerial Recognition Rules are clear that any sexual activity outside of heterosexual marriage is deemed gross misconduct. The specific clause (Appendix 3, Section 4.3) says:

'Sexual Misconduct which brings the church and ministry into disrepute. NB This specifically includes sexual intercourse and other genital sexual activity outside of marriage (as defined exclusively as between a man and a woman).'

Some members have requested that the last section in brackets is removed, which would mean that a minister who is in a same-sex marriage would no longer be committing gross misconduct and lose their accreditation. The removal of the words in the brackets would change the current definition of marriage in the Ministerial Recognition Rules.
